written text. Many learners will develop these approaches without teacher guidance, adopting the strategies through trial and error as they look to better understand texts that challenge them. However, we know that on average, disadvantaged children are less likely to own a book of their own and read at home with family members, and for these reasons may not acquire the necessary skills for reading and understanding challenging texts.

- 6+ months progress has been found in Primary aged children
- Lower attaining pupils appear to benefit in particular from the explicit teaching of strategies to comprehend text.
- Studies in England have shown that pupils eligible for free school meals may receive additional benefits from being taught how to use reading comprehension strategies. (However, the UK evidence base is less extensive than the global average, and UK studies show lower impact for all pupils.)

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

Please note - Schools are not required to publish their 2022 key stage 2 results and the DfE is not publishing this data either. This is due to statutory assessments being taken for the first time since 2019, without adaptations, after disruption caused by the pandemic. This is a transitional arrangement for one year only due to the pandemic, and DfE plans to publish key stage 2 school performance data for 2023.

Intended outcome for the current 3 year strategy - To eradicate the gap between our disadvantaged children and non-disadvantaged children nationally.

When looking for impact on our intended outcomes of the implementation of our strategy, it can be difficult to separate what is impact due to the strategy spending specifically, compared to what other factors may have contributed to this impact Eg quality first teaching. The strategy spending has enabled maths, and reading interventions to take place all year as planned and progress has been measured by internal testing.

Reading progress for Y 3 & 4 PP children showed accelerated progress and was higher than Non PP children in our school. In Y5 however, this is not the case and further strategies are being explored.

Maths progress in year 3 also showed accelerated progress scores for PP children, but not quite as much as Non PP. Progress has also been good in Y5 for PP children, but again not inline with, or above, the Non PP children. Factors affecting this will need further consideration. Data suggests Y4 progress in maths generally is a cause for further investigations too, but for both groups.

The initial data for **Y6 SATs** shows that Scaled Scores in both subjects are roughly the same for both PP and Non PP groups. In **maths** the percentage achieving ARE by both groups is the same. In **Reading** there is a slight difference, with 5% less of PP children achieving ARE. Progress looks likely to be in-line with National progress – we are awaiting our validated data at this time to review and compare with national too.

Summary

The results so far suggest that we are moving towards achieving our aim – more time is needed to see the full impact and timely reviews are planned.

Direct Instruction will continue where most impact has been seen - Y3/4.

Pastoral support will continue – wellbeing surveys show improvements during the year of a 1.2 increase. This will result in a similar spend the last academic year.

Cultural Capital will be a continued focus – Explorer lunchtime activities to continue and develop. Pupil voice suggests that this is beginning to have a positive impact. Children have received these activities in a positive way and some have extended these experiences into their home setting.

Attendance evaluation has been tricky due to Covid – The attendance team are shown to have a clear impact from previous data, so this too must continue. Our November data shows that we have better attendance than primary schools nationally. Our PP attendance is also higher than National attendance figures. This focus must continue.

1:1 reading – This shows good impact on progress generally and also in the fostering of improved reading habits. This will continue to develop.
